

STATUTORY DECLARATION

I, Aidan Patrick McLindon
of 8 Grandview Rd, Jimboomba , in the state of
Queensland,

do solemnly and sincerely declare that:

I was requested by the LNP State Secretary, Mr Joel Harrop, on behalf of the LNP State President, Mr Bruce McIver, to attend a meeting to outline disciplinary action taken against me by the LNP organisation to be held on Thursday 4 February 2010 at LNP Headquarters.

I arrived on time and was met by Mr Harrop in the waiting room at approximately 10:10am. I was taken to the office of Mr McIver and shook hands with all present. From my left sat Mr Barry O'Sullivan, LNP State Treasurer, Mr Joel Harrop, LNP State Secretary, Mr Gary Spence, LNP Vice-President, Mr Bruce McIver, LNP State President, and directly to my right, Mr Michael O'Dwyer, LNP State Director. I was advised that Mr Mike Horan was linked to teleconference on phone in the capacity as LNP Party Whip.

The meeting commenced to discuss what disciplinary action would be taken against me by the organisation as a result of my engagement with the media on Thursday 28th January and Friday 29th January 2010.

After general discussion between all parties, with the exception of Mr Joel Harrop, I explained to those present how events unfolded.

Mr Barry O'Sullivan conducted himself in a most threatening and intimidating way shouting at the top of his voice along the lines of "If it wasn't for Bruce's intervention I would have thrown you out of the fucking party you fuckwit... I have never been so fucking angry in my fucking life and you're lucky you're still fucking here you little shit... Who the fuck do you think you are. What made you think you can fucking act like this when we're here trying to fucking run this thing... you only had four fucking MP's supporting you so why the fuck would you go in there and run for the Deputy Leadership" etc etc. In short Mr O'Sullivan lost his temper which produced an extremely volatile and intimidating environment. This abuse continued for quite some time.

Mr McIver read out to those present the course of action they intended to take was: 1. Write a letter of apology to himself as State President. 2. Mike Horan, as Parliamentary Whip would be appointed as my "mentor" whom I could liaise with to assist me with any issues that would arise. This would be reviewed in 6 months and again 12 months to monitor its progress. 3. I would be required to be a member of the Marginal Seats Campaign Committee at an expense of \$12,000 to be paid for and I quote "from my electorate allowance". I was told that Mike Horan would be provided with the necessary paperwork for me to sign on Monday to ensure I paid the sum of \$12,000 to the LNP Secretariat. Mr McIver also stated that this contribution was

being made by each of the members on this committee. (Note: MP's were advised that it is a mandatory requirement that all MP's who have a margin of less than 5% be a member of the committee. The Beaudesert Electorate in which I represent has a margin of 8.31%).

At this stage I was about to lose my temper but I remained calm and collected as I just wanted to get out of the environment I found myself in. I was asked if I had any questions at which I said no and that what they had outlined sounded reasonable. My heart was beating heavily and my mind was racing but I took a deep breath and remained calm. I shook hands with them all and left at about 10:40am.


Mike Horan was on teleconference line which was cut off about four fifths the way through the meeting as an engaged signal sounded on the phone. Michael O'Dwyer attempted to call him back on his mobile which went straight to his answering machine. I never actually heard Mike Horan say anything during the whole meeting, not even at the introduction to say he was on the other end of the line. The audio of the 'engaged signal' was well after the disciplinary actions were read out to me.

I received a phone call from Mike Horan the following day in relation to the meeting and he assured me that he would keep the contents of the meeting in confidence.

I emailed a letter of apology to Mr McIver at 9:06pm on 4 February. That evening Mr Joel Harrop called me several times on my mobile to email him a copy of the letter of apology to Mr McIver so that he could table it in the agenda for State Management to be held the next day on Friday 5 February. I emailed Mr Harrop a copy of this as requested at 10:38pm on 4 February. Mr McIver called me mid-afternoon on 5 February to say that my letter of apology remained with him and him only and that it was just between the both of us. At this point I was not sure whether or not it was intended for Mr McIver only, or, for the State Management Committee as Mr Harrop had requested a copy the night before.

I felt extremely uncomfortable about the situation. On Sunday evening I decided to write this statutory declaration as I felt what had taken place was not of a legal nature. I referred to the LNP's Constitution and was not satisfied in which the way the meeting was conducted as I believe that those members present did not constitute a Presidents Committee. I have now decided to seek legal advice on the matter.

AND I MAKE THIS SOLEMN DECLARATION CONSCIENTIOUSLY BELIEVING THE SAME TO BE TRUE, AND BY VIRTUE OF THE PROVISIONS OF THE OATHS ACT 1867 - 1988.

- M.29 The Party Unit or officer appointing a committee shall designate one of its members as chair of the committee.
- M.30 At a meeting of any committee which is not expressly otherwise provided for herein, a majority of its members shall be a quorum except that a quorum for Standing Committees appointed by State Council shall be a majority of the Committee or seven, whichever is the less.

N PRESIDENT'S COMMITTEE

- N.1 There shall be a President's Committee comprising the President, the Vice-President, the Treasurer, the Honorary Legal Advisor and the Immediate Past President to be known as The President's Committee.
- N.2 In the event of any exigency arising between meetings of the State Executive, the President's Committee is empowered to take such action in relation thereto as it considers to be appropriate in the interests of the Party.
- N.3 The President's Committee may meet informally but a record is to be maintained of any action taken pursuant to the powers hereby conferred and such action is to be reported and submitted for ratification to the next meeting of State Executive.
- N.4 In the event that after reasonable efforts a member of the President's Committee cannot be consulted, a decision of the President and other members of the President's Committee will be deemed to be the decision of the Committee.
- N.5 A resolution signed by each member of the Committee or, if a Member cannot reasonably be consulted and the minute contains a note to that effect, by the President and the other Members shall be as valid and effectual as a decision of a meeting of the Committee. The resolution may be in one or more paper writings, or facsimile or in the form of e-mail in which event it is afterwards to be reduced to writing for presentation and ratification to the State Executive.
- N.6 Should a resolution of the President's Committee be not ratified, the resolution shall be deemed not authorised to proceed further but shall be valid up to that date.

O STATE PARLIAMENTARY PARTY

- O.1 The State Parliamentary Party shall consist of Members elected to the State Parliament as candidates endorsed by the Party and such other Members who are elected to the State Parliament as the Party shall determine.
- O.2 The State Parliamentary Party shall appoint a Leader, Deputy Leader and such other officers as it may decide and shall govern its affairs according to its own rules.
- O.3 The State Parliamentary Party shall be responsible for the implementation of the Party platform in the state sphere as far as is possible.
- O.4 The State Parliamentary Party shall consider policy decisions of State Council and State Convention forwarded to it and shall communicate its decision in respect of such decisions and the reasons therefor to the State Executive within a reasonable time of the State Parliamentary Party's receipt of the same and in any event before the next meeting of State Council or Annual State Convention.

P AUSTRALIAN PARLIAMENTARY MEMBERS

- P.1 Members elected to the Australian Parliament shall govern their affairs in accordance with the rules of the parliamentary parties of which they are respectively Members in accordance with the provisions hereof.
- P.2 It shall be the responsibility of members of the Party in the Australian Parliament to implement the Party platform as far as is possible.

- B Headquarters has designed a marginal seat campaign to ensure success on election day.
- C The MP wishes to be part of the marginal seat campaign.
- D Both parties acknowledge that the success of this partnership will require cooperation, discipline and, above all, the desire and drive to show the people of Queensland that the LNP has the candidates and the policies to be a government committed to restoring Queensland to prosperity.
- E Each party wishes to outline the responsibilities that it has to the other in that regard and the steps that each will take towards achieving the common goals.

It is agreed

1 Definitions and interpretation

1.1 Definitions

In this Compact:

- (1) **Local Campaign Module** means
 - (a) identification and development of an issue significant to your electorate;
 - (b) drafting media releases and/or letters to the editor
 - (c) assistance with researching the issue and development of material, if appropriate

(2) **Practical Campaign Support** includes:

- (a) regular Field Officer visits to advise and assist the MP or SEC to develop a campaign plan for the electorate and to support your implementation of that plan;
- (b) ensuring effective use of Feedback and other electronic database systems available to the LNP;
- (c) coordinating shadow ministerial visits in conjunction with the leader's office and whip;
- (d) assisting with fundraising and community events;
- (e) following up and measuring the outcome of local promises.

(3) **State Campaign Module** means campaign support which may include:

- (a) localised or shell media releases;
- (b) talking points on local and State issues;
- (c) artwork for addressed and unaddressed mail, such as flyers and letters;
- (d) flyers and brochures;
- (e) corflutes;
- (f) text / graphics for email distribution;
- (g) letters to the editor;
- (h) phone canvassing scripts;
- (i) print / radio advertising material.

1.2 **Interpretation**

(1) Reference to:

- (a) one gender includes the others;
- (b) the singular includes the plural and the plural includes the singular;
- (c) a person includes a body corporate;
- (d) a party includes the party's executors, administrators, successors and permitted assigns;
- (e) a thing includes the whole and each part of it separately;
- (f) a statute, regulation, code or other law or a provision of any of them includes:
 - (i) any amendment or replacement of it; and
 - (ii) another regulation or other statutory instrument made under it, or made under it as amended or replaced; and

- (g) dollars means Australian dollars unless otherwise stated.
- (2) "Including" and similar expressions are not words of limitation.
- (3) Where a word or expression is given a particular meaning, other parts of speech and grammatical forms of that word or expression have a corresponding meaning.
- (4) Headings and any table of contents or index are for convenience only and do not form part of this Compact or affect its interpretation.
- (5) If an act must be done on a specified day which is not a Business Day, it must be done instead on the next Business Day.

2 Parties roles and responsibilities

2.1 Headquarters will:

- (1) deliver at least 4 State Modules during the first and any successive 12 month period of this Compact;
- (2) deliver at least 3 Local Modules for the first and any subsequent 12 month period of this Compact, and
- (3) provide the MP and SEC with Practical Campaign Support.

2.2 The MP will:

- (1) commit to raising sufficient funds to cover the financial commitment to the program and ensure that deposits are made to the relevant segment account bi-monthly in advance in the sum of \$2,000, the first payment to be made on entering into this Compact and then on the first day of each second month;
- (2) in conjunction with the SEC, coordinate and deliver State Modules to the electorate in a timely and efficient manner;
- (3) in conjunction with the SEC, coordinate and deliver Local Modules to the electorate in a timely and efficient manner;
- (4) in conjunction with the SEC, put in place a process to identify local issues to Headquarters;
- (5) nominate a single delivery point for material to be delivered to the SEC or the office of the MP;
- (6) ensure that sufficient funds are in the SEC account to meet the obligations under this Compact; and
- (7) authorise (which it hereby does) the LNP State Secretary to withdraw funds from the SEC account to meet any obligations under this Compact.

3 Financial Commitment

- 3.1 The MP agrees to pay \$12,000 per annum for provision of the abovementioned services.

4 Term of this Agreement

- 4.1 This agreement will commence on the date of its execution and conclude on the date of the next Queensland State Election.
- 4.2 The parties presently anticipate that the term will be approximately 2 years but may be shorter if an election is called early.
- 4.3 Should there be an early election, the intent of this Compact is that the obligations of both parties cease on the election date, and any amount paid by the MP in advance will be refunded pro rata, assuming a 30 day calendar month.

5 Further assurance

- 5.1 Each party must promptly at its own cost do all things (including executing and if necessary delivering all documents) necessary or desirable to give full effect to this Compact.

6 Entire understanding

- 6.1 This Compact:
- (1) is the entire Compact and understanding between the parties on everything connected with the subject matter of this Compact; and
 - (2) supersedes any prior Compact or understanding on anything connected with that subject matter.

7 Variation

- 7.1 An amendment or variation to this Compact is not effective unless it is in writing and signed by the parties.

8 Waiver

- 8.1 A party's failure or delay to exercise a power or right does not operate as a waiver of that power or right.
- 8.2 The exercise of a power or right does not preclude either its exercise in the future or the exercise of any other power or right.
- 8.3 A waiver is not effective unless it is in writing.
- 8.4 Waiver of a power or right is effective only in respect of the specific instance to which it relates and for the specific purpose for which it is given.

9 Notices

- 9.1 A notice or other communication connected with this Compact (**Notice**) has no legal effect unless it is in writing.
- 9.2 In addition to any other method of service provided by law, the Notice may be:
- (1) sent by prepaid post to the address of the addressee set out in this Compact or subsequently notified;

- (2) sent by facsimile to the facsimile number of the addressee; or
 - (3) delivered at the address of the addressee set out in this Compact or subsequently notified.
- 9.3 If the Notice is sent or delivered in a manner provided by clause 9.2, it must be treated as given to and received by the party to which it is addressed:
- (1) if sent by post, on the 2nd Business Day (at the address to which it is posted) after posting;
 - (2) if sent by facsimile before 5pm on a Business Day at the place of receipt, on the day it is sent and otherwise on the next Business Day at the place of receipt; or
 - (3) if otherwise delivered before 5pm on a Business Day at the place of delivery, upon delivery, and otherwise on the next Business Day at the place of delivery.
- 9.4 Despite clause 9.3(2):
- (1) a facsimile is not treated as given or received unless at the end of the transmission the sender's facsimile machine issues a report confirming the transmission of the number of pages in the Notice; and
 - (2) a facsimile is not treated as given or received if it is not received in full and in legible form and the addressee notifies the sender of that fact within 3 hours after the transmission ends or by 12 noon on the Business Day on which it would otherwise be treated as given and received, whichever is later.
- 9.5 A Notice sent or delivered in a manner provided by clause 9.2 must be treated as validly given to and received by the party to which it is addressed even if:
- (1) the addressee has been liquidated or deregistered or is absent from the place at which the Notice is delivered or to which it is sent; or
 - (2) the Notice is returned unclaimed.
- 9.6 Any Notice by a party may be given and may be signed by its solicitor.

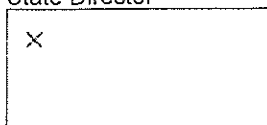

6 Entire understanding

6.1 This Compact:

- (1) is the entire Compact and understanding between the parties on everything connected with the subject matter of this Compact; and
- (2) supersedes any prior Compact or understanding on anything connected with that subject matter.

7 Variation

- 7.1 An amendment or variation to this Compact is not effective unless it is in writing and signed by the parties.

8 Waiver

- 8.1 A party's failure or delay to exercise a power or right does not operate as a waiver of that power or right.
- 8.2 The exercise of a power or right does not preclude either its exercise in the future or the exercise of any other power or right.
- 8.3 A waiver is not effective unless it is in writing.
- 8.4 Waiver of a power or right is effective only in respect of the specific instance to which it relates and for the specific purpose for which it is given.

9 Notices

- 9.1 A notice or other communication connected with this Compact (**Notice**) has no legal effect unless it is in writing.
- 9.2 In addition to any other method of service provided by law, the Notice may be:
- (1) sent by prepaid post to the address of the addressee set out in this Compact or subsequently notified;
 - (2) sent by facsimile to the facsimile number of the addressee; or
 - (3) delivered at the address of the addressee set out in this Compact or subsequently notified.
- 9.3 If the Notice is sent or delivered in a manner provided by clause 9.2, it must be treated as given to and received by the party to which it is addressed:
- (1) if sent by post, on the 2nd Business Day (at the address to which it is posted) after posting;
 - (2) if sent by facsimile before 5pm on a Business Day at the place of receipt, on the day it is sent and otherwise on the next Business Day at the place of receipt; or
 - (3) if otherwise delivered before 5pm on a Business Day at the place of delivery, upon delivery, and otherwise on the next Business Day at the place of delivery.
- 9.4 Despite clause 9.3(2):
- (1) a facsimile is not treated as given or received unless at the end of the transmission the sender's facsimile machine issues a report confirming the transmission of the number of pages in the Notice; and
 - (2) a facsimile is not treated as given or received if it is not received in full and in legible form and the addressee notifies the sender of that fact within 3 hours after the transmission ends or by 12 noon on the Business Day on which it would otherwise be treated as given and received, whichever is later.

9.5 A Notice sent or delivered in a manner provided by clause 9.2 must be treated as validly given to and received by the party to which it is addressed even if:

- (1) the addressee has been liquidated or deregistered or is absent from the place at which the Notice is delivered or to which it is sent; or
- (2) the Notice is returned unclaimed.

9.6 Any Notice by a party may be given and may be signed by its solicitor.
